Dues and fees are reevaluated annually as part of the planning and budgeting process. The fees shown here cover the 2010-2011 membership year only. Call Jodi Nussbaum at 973.655.1739 with any questions about services, education, finances or anything else about Ner Tamid.

Membership Dues

The 2010-2011 fiscal year starts June 1, 2010 and ends on May 31, 2011. Members joining between June 1 and January 1 are responsible for a full year's dues. Members joining after January 1 pay one half of the fiscal year's dues. 2010-2011 fiscal year dues categories are:

- Family Membership (2 adults regardless of religious affiliation with or without children) \$2,325 includes two High Holy Day tickets plus High Holy Day tickets for your children under age 23
- Single Membership (1 adult with or without children) \$1,260 includes one High Holy Day ticket plus High Holy Day tickets for your children under age 23

Building Fund

All new members pay \$2250 towards Ner Tamid's building fund. This may be paid over six years at a minimum of \$375 per year. If you can provide records of comparable contributions to another synagogue's building fund (such as a letter to us from that synagogue), all or part of this responsibility can be waived.

Religious School Tuition

New members who wish to enroll children in the Ner Tamid religious school should also complete and submit religious school applications, and should make an appointment to talk to our Education Director, Iris Schwartz, who can be reached at the Ner Tamid office. For the 2010-2011 school year, tuition per child is:

- Temple Tots (pre-K) \$180 Grades K-2 \$700
- Grades 3 - 6 \$925 Grade 7 \$850
- Grades 8 -12 \$700 B'nai Mitzvah \$945 (additional charge)

Payment Schedule

You incur a full year's financial obligation at the beginning of each fiscal year, we would greatly appreciate payment of dues, building fund and tuition at that time. Dues each year may be paid over the course of the year (without interest) as long as you pay a minimum of 33% by 9/1/10, 66% by 11/1/10, and 100% by 2/1/11. B'nai Mitzvah fee payable before the bar/bat mitzvah. **New members must submit at least the minimum payment amount due at the time of their application.**
